If you are a successful bidder, you will be notified shortly after the auction. A professional, third-party shipper will be used, arranged & coordinated by us **but paid for by you the buyer**. The Auction Co. reserves the right to hold merchandise purchased by personal check until the check has cleared the bank, if the Auctioneer deems such action necessary to protect his interest. Once the 3rd party shipper takes possession of auction items, they have the right to charge appropriate handling and insurance charges.

If you are unable to attend the auction but would like to bid, you can submit "Absentee & Telephone Bid Forms" by mail or fax and Auction Co. will bid competitively with other bidders on your behalf. Please fill out form completely and *SIGN*. No forms will be accepted without your signature and credit card information.

ABSENTEE BIDS

- 1) Fill out the "Absentee & Telephone Bid Form" provided. Indicate the lot number, a brief description and the amount you wish to bid for each item.
- 2) Indicate if you wish to bid to the next highest increment if your high bid is on the floor.
- 3) You will be contacted following the sale *IF* you are a successful bidder.
- 4) In the event identical bids are submitted, the earliest will take precedence.
- 5) Absentee bids shall be executed in competition with bids from the audience.
- 6) **Auction Co. assumes no responsibility for failure to execute absentee bids or for failure to implement any subsequent modifications of bids by bidder.**
- 7) Auction Co. will ship merchandise through a professional, third-party shipper **at the expense of the Buyer** upon receipt of payment.

TELEPHONE BIDS
